As stated on Certification 025, 96-97 and reaffirmed with the approval of the Certification 123, 05-06, of our Board of Trustees, the University of Puerto Rico at Carolina has been guided by a Systemic Strategic Plan defined by goals, objectives and emblematic initiatives. This guidance has created an organizational behavior tending to create a culture based on strategies goals and objectives, facilitating the processes of planning, resource allocation by initiative and academic priorities. In order to integrate the GenEd goals into the curriculum as a whole, the proposal, A Re-Conceptualization of General Education, was approved by the UPR Academic Senate in 2006 (Certificación Núm. 20 (2006-2007), to specifically align GenEd goals with the B.A. Co-Curricular and Concentration Courses. This involved revising B>A, programs to increase the number of credits. All programs now offer 44 GenEd credits. Each GenEd goal is aligned with GenEd core courses, the same courses for all programs, and with specific co-curricular and concentration courses with embedded GenEd goals for each program. These revised programs are offered to incoming students. As affirmed on Certification 19(2009-2010), support services at UPRCA are included as part of the Institutional objectives that were carefully written in order to position them as a priority. These services offer the students an academic extended curriculum, orientation to reach their educational goals, and to help them with their personal lives as well.
